<p>Items for Writing the Examination:</p> <ul style="list-style-type: none"> • Photo identification showing complete legal name • Important: Must be a government issued photo ID (e.g., driver's licence, passport, or military ID). Health cards are not accepted. The first and last name printed on the photo ID must match exactly the first and last name submitted to the regulatory authority on the College of Kinesiologists of Ontario (CKO) examination application form. <p>Clothing:</p> <ul style="list-style-type: none"> • Layered clothing • Clothing with no pockets or a hood preferred • Important: Proctors may require candidates to remove hats or head covering (except for religious head wear) that obstruct the eyes and face. This is done to maintain the security of the exam. Candidates have the right to refuse to remove the requested item, but if they do so, they will not be permitted to write the exam, which will be the equivalent of an automatic fail. <p>Cell phone – only required and permitted during check-in</p> <p>Personal Items:</p> <ul style="list-style-type: none"> • Special medical item authorized by the CKO • Important: The personal items noted above must be visible at all times on your desk. Any other personal items must be stored in a designated area outside of the exam room <p>Beverage: including water or juice with label removed.</p>	<p>Strictly prohibited items:</p> <ul style="list-style-type: none"> × Any electronic or communication devices including but not limited to the following: <ul style="list-style-type: none"> - Cell phone/mobile phone – Except for during check-in - multiple screens - Paper - Personal digital assistant (PDA) - iPod/iPad - Digital Watch - Hand-held computer or laptop - Headphone/headset/earpiece - Calculator - Music equipment - Pager - Recording devices - Camera of any kind × Study materials of any kind, including but not limited to the following. <ul style="list-style-type: none"> - Books - Notes - Blank paper × Hats or head covering of any kind that obstructs the eyes or face (except for religious head wear), including but not limited to the following: <ul style="list-style-type: none"> - Baseball caps - Tuque (knitted cap) × Food, including candy and gum × Pencil or pens of any kind eraser 	<p>Special requests:</p> <ul style="list-style-type: none"> • Accommodations may be made for medical reasons at the discretion of the CKO based on submission of supporting medical documentation. Refer to our website for more information about accommodations. • To maintain the security of the exam, proctors are authorized to ask applicants to remove digital watches, head covering (except those worn for religious purposes) and any other non-essential items. An applicant has the right to refuse to remove such items, but if they refuse, they will not be permitted to write the exam, and this will be the equivalent of an automatic failure. No refunds will be issued in such cases. <p>Important:</p> <ul style="list-style-type: none"> • Accommodations must be approved by the CKO prior to the exam date. • An accommodation for a special medical need must be requested in advance by the candidate and must be authorized by the CKO. • An accommodation to allow food will be made based on medical needs at the discretion of the CKO.
